

Jābir stated: "God's Messenger said: 'Cleaning with mudstones after defecation should be once only; the $ram\bar{\imath}$ of the columns should be once; the $sa'\bar{\imath}$ between Ṣafā and Marwā should be once; the $taw\bar{a}f$ should be once. When anyone of you cleans yourself with mud-stones after defecation, he should do it once only."

Abū al-Zubayr Muḥammad ibn Muslim ibn Tadrus al-Makkī (d. 116 AH) is a *mudallis* and variants have his 'an'anah.² Also though Abū al-Zubayr is regarded as trustworthy by many authorities, here is the *jarḥ* recorded on him by al-Mizzī.³ In the opinion of Nu'aym ibn Ḥammād, Ayyūb al-Sakhtiyānī regards him to be weak and in the opinion of Aḥmad ibn Ḥanbal, Sufyān ibn 'Uyaynah regards him to be weak. Ibn Abī Ḥātim's opinion about him is: *yuktabu ḥadīthuhū wa lā yuḥtajju bihī*. Abū 'Adī says that though he is reliable yet he has reported some narratives from *du'afā*'.

Shu bah has regarded Abū al-Zubayr to be da tf as well.
